#### **Nomination**

- All finalists will be verified and authenticated by an International professional credit information company.
- The organiser will submit the list of the finalists to the co-organisers and International Entrepreneur Councils for their professional advice and endorsement.

- Nominees may select their preferred award type. Please stated the priority if
  more than one is selected. However it is the prerogative of the judging panel
  to decide number of awards given and place nominee in the award type that
  allows the nominee for the best probability of receiving an award.
- All sections should be completed thoroughly as information provided will form the basis for judging. Please denote N/A where appropriate.
- All information provided in the nomination form will be treated with full confidentiality.
- The Organiser cannot undertake to return documents or supplementary material submitted with an entry.
- Names of applicants, commentary and scoring information developed during the review of applicants are regarded as proprietary by the Organising Committee and are kept strictly confidential. Such information is available only to those individuals directly involved in the assessment and administrative process.
- Withdrawal from the award in your own accord after submission is in breach
  of the terms of nomination and the authentication fee will not be refunded.
- Once the company is announced as a winner, he/ she cannot withdraw from the nomination and the sponsorship fee will not be refunded.
- The decision of the organisers is final and there will be anonymity of those not listed.
